The BoS also approved that such students who will leave MA (Education) programme (two years PG degree) after successful completion of two/three semesters can rejoin/re-enter/re-admit in the corresponding third/fourth semester (as the case may be) at a later stage and his/her previously earned credits shall be considered for completion of remaining part of MA (Education) two years PG degree programme.
