The Executive Council approved the recommendations of the Selection Committee(s).

The members of the Executive Council expressed their views that since the meetings of Selection Committees for various disciplines for different teaching positions are being scheduled frequently and it is not possible to call the meeting of Executive Council so frequently, therefore, all the members unanimously authorized the Vice-Chancellor to open the sealed recommendations of the Selection Committee(s) and issue the

appointment letters to the selected candidates, subject to ratification by the Executive Council in its next meeting.

Item No. 42.5

To place before the Executive Council the Enquiry Report against Dr. Navneet Sharma, Assistant Professor, Department of Education.

As per decision of the Executive Council on item No. 40.4 in its 40th meeting held on 30.08.2019 the report of the Enquiry Officer submitted on Enquiry against Dr. Navneet Sharma was further placed before the Executive Council for its decision in the matter.

The Executive Council considered the report of the Enquiry conducted against Dr. Navneet Sharma, Assistant Professor and decided to issue the letter censuring Dr. Navneet Sharma in the matter. The Executive Council further directed the University to return the necessary evidence material belonging to the Complainant, which were submitted by him during the proceedings, under proper receipt and identification.

Item No. 42.6

To place before the Executive Council the Report of the Committee constituted for verification of documents regarding recruitment of Md. Suaib Khan, UDC.

A Committee was constituted by the Hon'ble Vice-Chancellor to look into the documents regarding recruitment of Md. Suaib Khan, UDC and others. The Committee vide letter dated 20.12.2017 submitted its report to the Vice-Chancellor which is being placed before the Executive Council.

The report of the Committee constituted to look into the recruitment of Md. Suaib Khan, UDC and others was discussed and report of the Committee was approved and accepted by the Executive Council unanimously.

Item No. 42.7

To place before the Executive Council the reply of the Dr. Asutosh Pradhan, submitted in connection with a grievance received by the University through MHRD on CPGRAMs.

A grievance vide No. PMOPG/E/2018/0478430 dated 8.10.2018 was received from Mr. Bhushan Kumar through MHRD on CPGRAMS. In this connection, the initial reply as per records was uploaded on CPGRAMS and subsequently, Mr. Bhushan Kumar against filed grievance against Dr. Asutosh Pradhan. In this background

Dr. Asutosh Pradhan was asked to clear his position in writing. Accordingly the reply so received from Dr. Asutosh Pradhan vide his letter dated 18th July, 2019 was placed before the Executive Council.

The Executive Council after going through the reply submitted by Dr. Asutosh Pradhan in connection with a grievance received through MHRD on CPGRAMs authorized the Vice-Chancellor to constitute a Committee to look into the reply submitted by Dr. Asutosh Pradhan and submit its report to the Executive Council.

With the permission of the Chair, the following items were placed before the Executive Council on the spot:-

Item No. 42.8

To place before the Executive Council the matter regarding disposing-off the old recruitment record.

The Chairman apprised the Executive Council that since inception of the University the recruitment of Teaching and Non-Teaching staff were conducted by the University and the entire recruitment record for example, application forms, API forms, API record, etc. etc. are being kept by the University which has become bulk. Accordingly the matter is placed before the Executive Council to take necessary decision regarding this bulk recruitment record.

The Executive Council recommended that the record pertaining to the recruitment of Teaching and Non-teaching staff including applications should be destroyed after two years except the documents and application forms of the applicants who were selected and joined in the University.

Item No. 42.9

To place before the Executive Council the matter regarding transfer of one post of Associate Professor.

The Chairman brought to the notice of the Executive Council that there is a provision for Centre for Tibetan Studies in the Statute 40 of the University and proposed that one post of Associate Professor sanctioned under School of Commerce & Management Studies may be diverted to the Centre for Tibetan Studies.

The Executive Council considered the proposal of the Chairman and approved that one post of Associate Professor (un-reserved) sanctioned under School of Commerce & Management Studies is diverted to the Centre for Tibetan Studies till the teaching positions for the Centre are sanctioned by the UGC.
