## **MINUTES**

Item No. 51.1:

To place before the Executive Council, Annual Quality Assurance Reports (AQAR) for the years 2016-2017, 2017-2018, 2018-2019, 2019-2020 and 2020-2021 already passed from the Academic Council vide Item No. 28.6 in its 28th meeting held on 28th August, 2021.

The matter regarding Annual Quality Assurance Reports (AQAR) of the University has been placed before the 28th Academic Council meeting held on 28th August, 2021 at 11:00 AM. The Academic Council considered and deliberated on the Reports under Agenda Item No. 28.6. Following agenda item was placed before the Academic Council:

"The National Assessment and Accreditation Council (NAAC) after assessment in 2017 accredited the Central University of Himachal Pradesh with B++ Grade. The validity of the assessment is up to May 01, 2022. The process for fresh assessment and accreditation is due for which Self Study Report (SSR) is to be prepared and further submitted to NAAC well in time. However, for preparing and submitting SSR, the submission of the Annual Quality Assurance Reports for the academic years 2016-2017, 2017-2018, 2018-2019, 2019-2020 and 2020-2021 to the NAAC, Bangalore is a mandatory obligation.

Therefore, the Annual Quality Assurance Reports(AQAR) for the academic years 2016-2017, 2017-2018, 2018-2019 & 2019-2020 and 2020-21 are placed as ANNEXURE-28.6(A) for perusal, consideration

and approval of the Academic Council so that these can be submitted to NAAC before 31st August, 2021."

The Academic Council considered and approved the Annual Quality Assurance Reports (AQAR) for the years 2016-2017, 2017-2018, 2018-2019, 2019-2020 & 2020-21 and further recommended to Executive Council for its approval.

The Annual Quality Assurance Reports for the academic years 2016-2017, 2017-2018, 2018-2019 and 2019-2020 are mandatory to be submitted to NAAC before 31st August, 2021 and the AQAR Report for 2020-21 is to be submitted to NAAC before 31st December, 2021.
