Item No. 25.3:

To place before the Academic Council the decision taken by the Vice-Chancellor to invite forty candidates against one vacancy of teaching positions.

The University has advertised various teaching positions vide advertisement No. 001/2019 dated 09.05.2019. The applications for these positions were scrutinized and screened as per UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018 and the Vice-Chancellor has approved to

invite/call forty (40) candidates against one (01) vacancy to be appeared before the Selection Committee. Accordingly, forty candidates against each vacancy were invited/called for the personal interviews which were conducted during the period September, 2019 to December, 2019.

The Academic Council approved the decision taken by the Vice-Chancellor to invite forty candidates against one vacancy of teaching positions for personal interview.

Item No. 25.4:

To place before the Academic Council the matter regarding approval of following Memorandum of Understanding (MoU).

The Institute of Company Secretaries of India(ICSI), Noida(U.P.) vide letter dated 06th December, 2019 has forwarded the proposal to entered into MoU with the University to introduce ICSI Signature Award Scheme in favour of Topper (One Medal) in the Full Time 2 Years MBA Course under the Department of HPKVBS, School of Commerce & Management Studies. Further, the top three students of CUHP, HPKVBS including topper for School of Commerce & Business Studies will be eligible for full waiver of ICSI Registration Fee for Executive Programme Stage. In addition to above the Signature award will be presented to student having Merit of Minimum CGPA (7.00) or merit of a minimum score of 60%. Item No. 25.5:

The Executive Council of the University vide Item No. 42.9 in its meeting held on 30.10.2019 has approved to start M.Phil courses in the following disciplines. Accordingly, the University has issued a Notice No. COE/2-2/H.P.K.V./2019 dated 06.12.2019 on the University website [ANNEXURE-25.5A]:

The Academic Council noted and approved the M.Phil Courses in the above mentioned Department/Centre of Studies.

The Academic Council also approved the activation of Centre for Tibetan Studies.

Item No. 25.6:

To place before the Academic Council the recommendations of different School Boards for consideration and approval.

Clause 15(2) of the Statute provides that every school shall have a School Board and the members of the first School Board shall be nominated by the Executive Council for a period of three years. Ordinance 22: Constitution, Powers and Functions of the School Board provides that, "The Board shall hold at least two ordinary meetings in an Academic year, one in each semester". Academic Council approved and recommended the Minutes of the above School Board(s) except Item No. 1.4 of Anneuxre-1 of 7th School Board of Physical & Material Sciences. The Academic Council approved to delete the item and suggested that the concerned department (DPAS) is authorized to work out the feasibility details and prepare a fresh guidelines regarding No. of seats/admission procedure and session of starting the integrated M.Sc.(Hons) Physics Programme.

Item No. 25.7

To place before the Academic Council the amendment to Ordinance No. 02 and 30 for consideration and approval.

A proposal from the Committee constituted by the Vice-Chancellor has been received to make **Amendments in Ordinance No. 02**: deals with Admission of Students and **Ordinance No. 30**: deals with Medium of Instruction, Examination, Evaluation and Grading System for Programmes of Studies Other than Research Degree Programme. The **Amended Ordinance No. 2** and **30** are placed as **ANNEXURE-25.7[A]** & **ANNEXURE-25.7[B]**.

The Academic Council after considering the proposed amended/repealed/reframed Ordinances No. 02 and 30 approved and further recommended the same to the Executive Council for its approval.

The following items were included by the permission of the Chairman

Prof. Roshan Lal Sharma, Incharge(Library) proposed that the name of Library established at Saptsindhu Parisar, Dehra should be named as "Prof. S.R. Rangnathan Pustkalaya", Sapt Sindhu Parisar, Dehra and name of Library at Dhauladhar Parisar, Dharamshla to be named as "Acharya Raghuvir Pustkalaya".

Prof. Rakesh Kumar, Dean, School of Mathematics, Computer & Information Sciences proposed to rename the Department of Mathematics as "Srinivasa Ramanujan Ganit Vibhag".

Prof. Mohan Lal Chhipa proposed that Post Graduation in Translation should be started in Hindi Department. He also suggested that the meeting proceedings should be written in Hindi. He further, added that one Course for Indian Contribution to that field in each Programme of Study may be included. Each Department should start job oriented Certificate/ Diploma

Courses. He also suggested that Bharat Vidya Adhyayan Kendra should be established in University.

Prof. Bhag Chand Chauhan, Dean, School of Physical & Material Sciences proposed that a monthly lecture series on Indigenous Science "<u>Maharishi Kanad Vyakhayan Mala</u>" should be started jointly by all Schools of Science faculty.

Lalitaditya Vyakhayan Mala will be conducted under Centre for Jammu & Kashmir Studies in future.

In case a student admitted to M.Lib & Information Sciences Programme opts out of the Programme after successful completion of 40 PG credits, he/she shall be awarded B.Lib & Information Sciences.

Dr. Jagmeet Singh, Head, Political Sciences proposed that Honorary Ph.D. Degree should be conferred by the Central University of Himachal Pradesh on renowned Punjabi writer and thinker, Sh. Ashwani Gupta.

At the end, Hon'ble Chairman proposed that Honorary Degree should be conferred on Sh. C.V. Gopinath renowned administrator and thinker. He also apprised the members that Department of Punjabi & Dogri under School of Languages and Department of Social Work shall be run at Sapt Sindhu Parisar, Dehra.

The Academic Council deliberated on the aforesaid suggestions of the members and approved all the items unanimously.
