### MINUTES OF 33<sup>RD</sup> MEETING OF THE ACADEMIC COUNCIL HELD BY CIRCULATION ON 21<sup>ST</sup> DECEMBER, 2022

**Item No. 33.1:** To place before the Academic Council the matter regarding Academic Calendar for the year 2022-23.

The University has started its Academic Session from 1<sup>st</sup> August 2022 of the 3<sup>rd</sup> & 5<sup>th</sup> semester & others (if any) as per Notification No. अ.अ./1-2/अकादमिक-कैलेंडर/हि.प्र.के.वि/22/217-26 दिनांक 13.12.2022 [Annexure-33.1(A)], -as approved by the Vice Chancellor. Whereas, the session of the 1<sup>st</sup> Semester started from the 7<sup>th</sup> November, 2022, since the admission of the 1<sup>st</sup> Semester was started after declaration of results of the entrance test (CUET) which was declared on UG-16.09.2022 & PG-26.09.2022 by the National Testing Agency. The Academic Council considered the Academic Calendar 2022-23 of the University and recommended the same to the Executive Council for its approval.

Item No. 33.2:

To place before the Academic Council the Memorandum of Understanding to be signed by the University with the different Agencies/Government Departments, Bodies /institutions autonomous Bodies.

The Central University of Himachal Pradesh has received the proposal from different Agencies/Government Departments, Bodies /institutions autonomous Bodies for collaborations for research and academic related activities. As per provision in the clause no. 5 and 6 of the University Ordinance 27, a Committee shall examine the proposal taking into consideration all aspects involving rights and obligations of the University and will make recommendations as to whether it is in the interest of the University to enter into the MoU. Clause 5 and 6 clause of the University Ordinance 27 is as under:

***"5. Any proposal received and/or imitated by the University to enter into an MOU with other institutions shall be examined by a Committee comprising the following:***

- a. *The Pro Vice-Chancellor (PVC) or one of Deans, to be nominated by the Vice-Chancellor, who shall be the chairperson*
- b. *Two Faculty members not below the rank of Professor, to be nominated by the Vice-Chancellor*
- c. *Coordinator, External Relations*
- d. *The Deans of the Schools concerned*
- e. *The Finance Officer*
- f. *The Registrar, who shall be the member Secretary*



**6. The Committee, referred as above, shall examine the proposal taking into consideration all aspects involving rights and obligations of the University and will make recommendations as to whether it is in the interest of the University to enter into the MOU."**

In view of the above, the University has constituted a Committee vide Notification No. 1-8/CUHP/Acad/2015 /MoU's/Vol. II 5397-11 dated 23.08.2021. The meeting of the Committee was held on 10.11. 2022 and recommended that the following proposals of the MOUs shall be signed:

- i. Institute of Advanced Studies in Education (Deemed to be University), Sardarshahr, District Churu, Rajasthan [Annexure-33.2(A)]
- ii. Asiatic Society for Social Science Research, New Delh, India [Annexure-33.2(B)]
- iii. Sardar Patel University(SPU), Mandi, Himachal Pradesh [Annexure-33.2(C)]
- iv. DRDO-Defence Institute of High-Altitude Research (DIHAR), Leh, UT Lakdakh [Annexure-33.2(D)]
- v. Dr. Rajendra Prasad Government Medical College, Tanda, Kangra [Annexure-33.2(E)]
- vi. Umbrella Memorandum of Understanding between ICAR Institutes [Annexure-33.2(F)]
- vii. M/s. Shivalik Solid Waste Management Limited (SSWML) [Annexure-33.2(G)]
- viii. Sher-e-Kashmir University of Agricultural Sciences and Technology of Jammu (SKUAST-Jammu) [Annexure-33.2(H)]
- ix. Sri Sathya Sai Educare Vidya Pratishtan, Khalui, Narwana Khas Panchayat Dharamshala [Annexure-33.2(I)]
- x. Central University of Punjab , Guddha [Annexure-33.2(J)]
- xi. Suraksha Bio Sanitizer, Vill. Dughiari, PO Gaggal Tehsil & Dist. Kangra H.P. [Annexure-33.2(K)]

As per provision contained under Ordinance No. 27 that deals with: procedure for Co-operation and Collaboration with other Universities, Institutions and other Agencies including Learned Bodies or Associations, he Academic Council may consider the recommendations of the constitute Committees, further recommendations for approval of the Executive Council.

**The Academic Council considered the aforesaid 11 MoU(s) and further recommended them to the Executive Council for their approval.**

**Item No. 33.3:** To place before the Academic Council the matter regarding amendments to Ordinance No. 42 dealing with 'Medium of Instruction, Examination, Evaluation and Grading System for the Award of Doctor of Philosophy'.

The University has constituted a committee vide Office Order F.No. 3-3/CUHP/GA/2010/Vol.IV/5944-54 dated 01.09.2022 to make review in the University Ordinance No. 42. The Dean (Academic) conducted several meeting with the faculty members (Ph. D Supervisor) and RD Scholars of all the Campuses to resolve the various related issues and suggested that there are certain Clauses & Forms of the Ordinance 42 to be revised.

The Controller of Examinations also requested to make necessary amendments in the University Ordinance 42 and its various forms required for PhD Programmes. Therefore, the Committee perused the matter and made its recommendations [**Annexure-33.3(A)**].

As per recommendations of the Committee and on the approval of Vice-Chancellor, the University has notified the amendments vide Notification No. 3-3/CUHP/GA/2010/Vol.IV/5239-41 dated 20<sup>th</sup> September, 2022. [**Annexure-33.3(B)**].

**The Academic Council considered the proposed amendments / reapplements in University Ordinance No. 42 dealing with Medium of Instruction, Examination, Evaluation and Grading System for the Award of Doctor of Philosophy and recommended the same to the Executive Council for approval.**

**Item No. 33.4:** To place before the Academic Council the matter regarding repealment in Ordinance No. 24: Cadre Recruitment Rules including manner of appointment, other service conditions and emoluments of employees other than teachers and other academic staff.

The Cadre Recruitment Rules (CRR) drafted / finalized by the Committee in its meeting held on 19<sup>th</sup> December, 2022[**Annexure-33.4(A)**] in accordance with Model CRR received from University Grants Commission which were approved by the 57<sup>th</sup> Executive Council held on 16<sup>th</sup> December, 2022 vide Item No. 57.26. The CRRs so approved by the Executive Council were accordingly incorporated in the Ordinances of the University.

**The Academic Council considered the proposed amendments / repeal / amendment in Ordinance No. 24 dealing with Cadre**

Recruitment Rules including manner of appointment, other service conditions and emoluments of employees other than teachers and other academic staff and recommended the same to the Executive Council for approval.
