6. **Proof of Confirmation of fee submission received from SAMARTH Portal / payment gateway should be send to the department at email: sharmasubhu13@hpcu.ac.in Latest by 02nd July, 2024.**

7. The admitted candidate must report in person to the Chairman of the Admission Committee of the Department on **01-08-2024**, for registration and verification of academic qualifications/documents. He/ She must bring the following documents:

(a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:

i. Mark sheets of Matriculation and 10+2 and Graduation.

ii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).

iii. Kashmiri Migrant Certificate, if applicable.

iv. Persons with Disabilities Certificate, if applicable.

v. EWS Certificate, if applicable

(b) Original Documents to be submitted:

- i. Migration Certificate
- ii. Character Certificate
- iii. Self-declaration by student for intervening period/ over a gap of three years, if applicable
- iv. Employer's no objection certificate, if applicable
- v. Two Passport size photographs.
- vi. Aadhaar Card

8. The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.

NOTE:

- In case the number of applicants for any Undergraduate Programme of study is less than 10, the University reserves the right to not making admissions to the respective programme for a particular session.
- The intake capacity of the different programmes of study is only indicative and the university may reduce the intake depending on the availability of suitably qualified candidates, intellectual resources, Teacher/Faculty and other academic infrastructure.

9. The regular classes shall commence from **01 August 2024** tentatively. Any change in commencement of classes shall be intimated to all selected candidates through E-mail/University website.


10. In case the seats remain vacant, the **Second Selection** list will be displayed/ uploaded on University Notice Board/Website on **05th July 2024 after 5:00 PM.**
