In addition, Not a single candidate took admission in the BFA Sculpture for the academic session: 2023-24.As per norms, Programme may only run if Minimum 10 student took admission otherwise, Programme will discontinue from next session.

Thus, to pursue the University rules, BFA (Sculpture) and MFA (Sculpture) Programmes will be discontinuing from the next academic session (2024-25). The enrolment of the students is very less to run the Programmes. Secondly, Fine Arts
