Bharata has a very rich and versatile knowledge system and cultural heritage. The Bharatiya knowledge system was developed during the Vedic period, the Saraswati-Sindhu Civilization, the Middle Ages and practiced till the conditions of modern times. In this course, a special attention is given to the reasons of ideas occurrence in the ancient society, and connection with the concept of material world, and religious, social, and cultural beliefs. On the closer examination religion, culture and science have appeared epistemological very rigidly connected in the Bharatiya knowledge esystem. As such, this land has provided invaluable knowledge stuff to the society and the world in all the spheres of life, e.g. aeronautics, science, astronomy, mathematics, life science, medical science, architecture, art, music, dance, literature, and drama.
