
With reference to your application dated 08.03.2022 and subsequent Interview held on 08.03.2022, I am to inform you that Executive Director, NABI, has been pleased to award you Junior Research Fellow under the project "**Targeting vascular phosphate transporter genes for improving phosphate use efficiency in rice.**" In addition to the above, the grant of Junior Research Fellow to you shall be regulated as per the terms and conditions as follows:-

1. Your appointment is co-terminus with the project. It will not exceed beyond project. However anytime after completion of one year of tenure, your services can be terminated by giving one month notice period on the recommendation of reporting officer, if your work is not found to be satisfactory.
2. The award of Fellowship is for fixed tenure and does not imply any assurance or guarantee for subsequent employment by NABI to you. The awardee shall not lay claim to permanent absorption in NABI, after the expiry of Fellowship.
3. You will submit progress report of your research work one month before completion of two years duly forwarded by your reporting officer for consideration in extension/up gradation.
4. You shall be paid fellowship of Rs. 31000/- per month plus HRA as per project.
5. You shall be required to produce a certificate of medical fitness from the prescribed Government Medical Officer/Civil Surgeon at your own cost before joining.
6. You will be required to work six days a week.
7. You will be a full time researcher and conform to the rules, regulations, discipline and conduct as per NABI, norms in force from time to time.
8. In case you decide to appear for competitive examinations, you would invariably seek permission from the guide and inform NABI about it.
9. You shall not take any assignment other than those related to your approved research programme, paid or unpaid. Your taking up any assignment at any time during the course of fellowship shall lead to forfeiture of the entire fellowship amount in addition to disciplinary action as deemed fit.

10. You will not discontinue your fellowship without prior approval of NABI. In case you wish to discontinue the fellowship prior to completion of the tenure or attainment of original objectives of research, **you must submit the resignation to NABI through your reporting Officer at NABI one month in advance, indicating specific reasons for not continuing the Fellowship. The fellowship shall cease from the date stipulated in the NABI letter approving the resignation.** The Executive Director reserves the right to waive off the notice period of one month on payment of one month's fellowship in lieu or otherwise.
11. You must send a detailed consolidated report of the research work done during the entire period of fellowship on completion of the tenure/resignation of the fellowship, in the prescribed proforma, within one month from the date of completion/resignation.
12. You will keep NABI informed of your getting the higher degree, submission of thesis etc. and submission/acceptance/publication of any research paper arising out of the research work done during the tenure of the fellowship. You must acknowledge the support of NABI in all such publications.
13. Application for patent will be as per DBT guidelines.
14. No travelling allowance will be paid to you for reporting for duty.
15. Any service matter not specifically stated herein shall be determined by the Executive Director, NABI, whose decision shall be final and binding on both the parties to the contract.

If you are willing to accept the award on these terms and conditions, you may please communicate your acceptance within a week from date of receipt of this letter intimating the probable date of your reporting for duty within one month and submit the enclosed annexure with latest photograph affixed thereon, at the time of joining NABI.



Your appointment will be purely on temporary basis for one academic session, with the following terms and conditions:

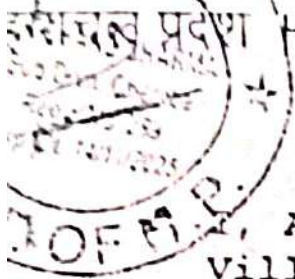
- (i) The candidate(s) who fulfilled the UGC/H.P. Govt. Norms will be paid minimum BP of UGC i.e. 15600/- pm. with Rs. 1000/- enhancement after completion of one year. However, they might be continued for the next academic session subject to examining their overall performance.
- (ii) The enhancement of Rs. 500/- pm shall be allowed to the existing staff, if they continued for the next academic session subject to examining their overall performance.
- (iii) The existing non-eligible teaching staff members will have to acquire NET/SLET (Minimum eligibility for the post of AP as per UGC Norms) within one year; otherwise their posts shall be treated as vacant and will be advertised for recruitment next time.
- (iv) Such eligible staff will have to go through the recruitment process after acquiring the Minimum eligibility for the post of AP as per UGC Norms.
- (v) The enhancement of Rs. 500/- pm shall be allowed to the existing Lab. Staff engaged on SFCs, subject to examining their overall performance.

- (vi) The enhancement in salary shall be subject to the availability of the funds and the Management Committee will have full right to roll back or decrease this annual increase, if there will be any crunch/shortage of funds in the SFC's account to meet out the expenditure of recurring or non-recurring nature in future.
- (vii) Every selected or existing re-engaged candidate(s) will have to submit an affidavit along with the clause that they are agreed to the annual increase or decrease of Pay as the case may be.
- (viii) The minimum fixed salary for Library Assistant shall be Rs. 8,000/- per month and the enhancement of monthly salary shall be as per norms for other staff after completion of one year.
- (ix) The vacation periods notified by the H.P. Univ. or Govt. of H.P. shall not count for the purpose of pay, however, the period of festival break during Diwali shall be counted for the purpose of pay.

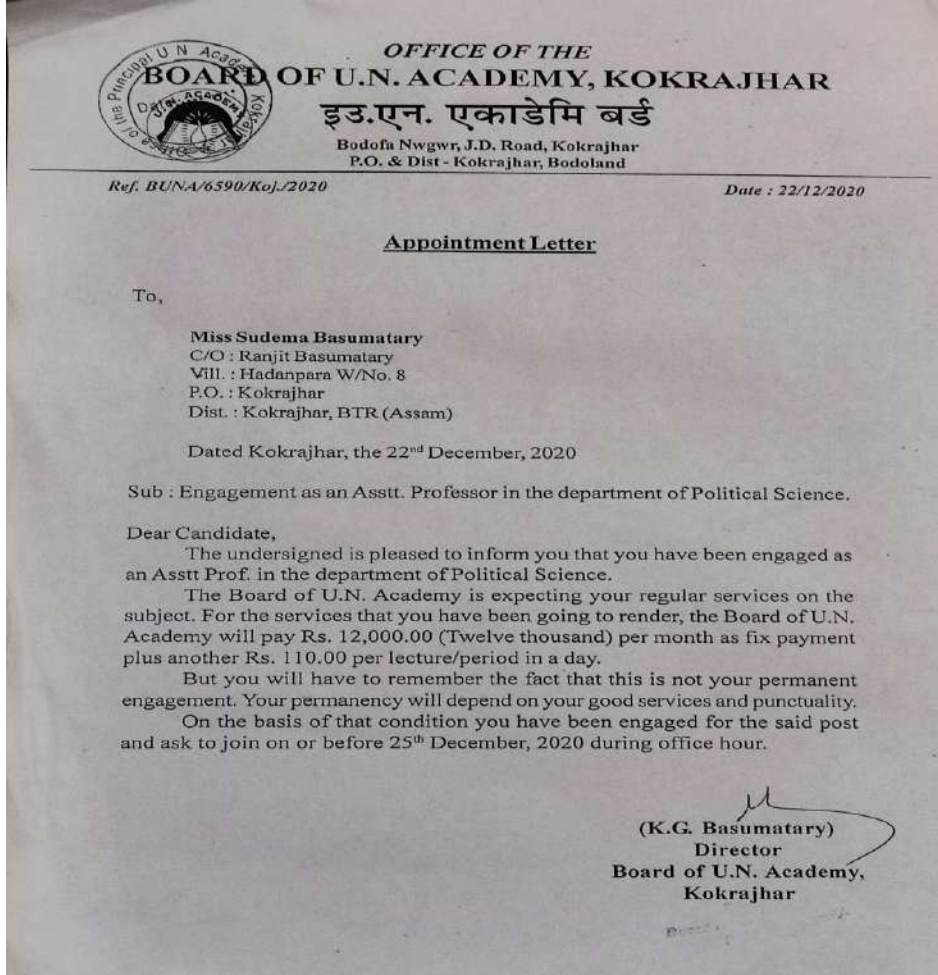
